SUSPENSION AND INTENDED REVOCATION OF APPROVAL OF A CLASS OF THE PRIME RETIREMENT & AGED CARE PROPERTY TRUST (ADMINISTRATORS APPOINTED) FINANCIAL PRODUCTS

This Bulletin is to notify all Participants that ASX Settlement has suspended approval of the below listed class of Financial Products issued by The Prime Retirement & Aged Care Property Trust (Administrators Appointed) (the "Issuer"):

The suspension took effect from 10.27am on Wednesday, 19 January 2011.

Pursuant to ASX Settlement Operating Rules 8.4.1(a) and 8.4.1(d), ASX Settlement has suspended the above listed class of the Issuer's approved Financial Products because ASX Limited has suspended trading in this class of the Issuer's approved Financial Products and following the appointment of Administrators.

Participants are advised that, as a result of the abovementioned suspension, in respect of the above listed class of the Issuer's approved Financial Products, CHESSE will only process Messages affecting Holder registration details. Transfer and/or Conversion Messages will not be processed, unless initiated by the Issuer.

Subject to ASX Settlement Rule 8.5.4, Participants are advised that ASX Settlement intends to revoke approval of the above class of the Issuer's Financial Products at End of Day on Thursday, 14 April 2011. At that time, all Holdings of the above class of the Issuer's approved Financial Products on the CHESSE Subregister will be converted to the Issuer Sponsored Subregister. At the time the approval is revoked, the CHESSE Subregister will be closed. This means that no Messages to CHESSE regarding this class of Financial Products will be processed after End of Day on Thursday, 14 April 2011.
